LJB's Cookin' Corner

HOMEMADE PEANUT BUTTER DOG TREATS

Since Sophie has been out of school, she's been doing a lot of baking. I've come home from the office to cookies, cupcakes, cakes, brownies and cinnamon rolls.

Lindy thought it would be a good idea to focus some of her efforts on baking for Sparta to give the rest of the family a sugar break. So they have been researching homemade treats that Sophie can make for Sparta. We've got all the ingredients in our next grocery pick-up order. Hopefully, Sparta and Sophie both enjoy the activity! I'll update you next month!



2. In the bowl of an electric mixer fitted with the paddle attachment, beat pumpkin puree, peanut butter and eggs on medium-high until well combined, about 1-2 minutes. Gradually add 2 1/2 cups flour at low speed, beating just until incorporated. Add an additional 1/4 cup flour at a time just until the dough is no longer sticky.
3. Working on a lightly floured surface, knead the dough 3 to 4 times until it comes together. Using a rolling pin, roll the dough to 1/4-inch thickness. Using small cookie cutters, cut out desired shapes and place onto the prepared baking sheet.
4. Place into oven and bake until the edges are golden brown, about 20-25 minutes. **
5. Let cool completely.

* Make sure the peanut butter does not contain Xylitol. Xylitol is a sugar substitute that is extremely poisonous to dogs.

** Baking time will vary depending on the size and thickness of the treats. Serving size will also vary depending on the desired shapes and cookie cutters used.

INGREDIENTS

- 2/3 cup pumpkin purée
- 1/4 cup peanut butter*
- 2 large eggs
- 3 cups whole wheat flour, or more, as needed

PREPARATION

1. Preheat oven to 350 degrees F. Line a baking sheet with parchment paper or a silicone baking mat; set aside.



SSDI Cases: If your case is currently awaiting a decision or a hearing, SSA continues to process cases. If you are currently receiving monthly SSA benefits, those should continue without interruption.

Personal Injury Cases: We continue working on our personal injury cases, and they are progressing as expected. If a lawsuit was filed or will be filed in your case, all deadlines and hearings have been extended during this crisis by order of the Louisiana Supreme Court and Governor.

Family Law Cases: Unless your matter involves an emergency situation, all

deadlines and hearings have been extended during this crisis by order of the Louisiana Supreme Court and Governor.

ERISA Long-term Disability Cases: We continue working on our long-term disability cases, and they are progressing as expected. If a lawsuit was filed or will be filed in your case, most deadlines and hearings have been extended during this crisis by order of the Court. If you are receiving monthly payments from an insurer, those should continue without interruption.
